The Board is pleased to announce that the Company has recently received the original of the certificate of registration of change of corporate name of non-Hong Kong company issued by the Registrar of Companies in Hong Kong, evidencing the registration of “FIH Mobile Limited 富智康集團有限公司” as the new English and Chinese names of the Company in Hong Kong under Part XI of the Companies Ordinance (Chapter 32 of the Laws of Hong Kong) with effect from 24 June 2013.

As to the trading of the Company’s shares on The Stock Exchange of Hong Kong Limited, the Chinese stock short name of the Company will be changed from “富士康國際” to “富智康集團” with effect from 3 July 2013. For the avoidance of doubt, the English stock short name of the Company will remain unchanged as “FIH” and the stock code of the Company will remain unchanged as “2038”.

The Company will also make further announcement on the consequential change of its website when the same becomes effective.

Reference is made to the announcements of FIH Mobile Limited (formerly known as Foxconn International Holdings Limited) (the “Company”) dated 21 March 2013, 30 May 2013 and 14 June 2013 respectively.
